Dear Mr. Beevers.

This letter supplements MARAD's letters of September 23 and 24, 2022, and responds to your September 27, 2022 letter. In our prior letters, MARAD informed you that it could not conduct a retroactive market survey of vessel availability for the waiver requests submitted by British Petroleum Products North America (BPPNA) under 46 U.S.C. § 501(b) because the vessels were already underway. In your September 27, 2022 letter, you request that MARAD conduct a retrospective survey of the industry to determine whether U.S.-flag coastwise-qualified vessels would have been available on September 15, 2022, the load date for the GH PARKS. We requested information from the industry about vessel availability in response to CBP's requests. Based on the responses received, it appears that the following U.S.-flag coastwise-qualified vessels could have been available on that date.

Since the time of your original request we have also reviewed a letter from the Governor of Puerto Rico, dated September 27, 2022, describing the emergency status on the island caused by Hurricane Fiona. In that letter the Governor—the principal leader responsible for response and recovery efforts on the island—describes an ongoing emergency where "[a] shortage of diesel and other fuel products will have an impact on our ability to provide essential services to citizens in Puerto Rico, thus affecting public health, security and continuity of government functions." The letter from Puerto Rico's Governor describes an immediate need for fuel to be delivered within hours. If the national defense requirement is determined to be immediate delivery of the diesel fuel, then based on the results of the survey and ongoing outreach to industry and Federal agency partners, no U.S.-flag vessels appear to be available to deliver fuel immediately.
