

Notice of Made in America Law Waiver Request – GC Asset Holdings LLC

Action: Notice, request for comments.

Web posting date: August 5, 2026

Close of public comment period: 15 days following the web posting date.

Summary: The Maritime Administration (MARAD) is seeking comments on whether a waiver of the domestic content requirement set forth in 46 CFR 298.13 should be granted to permit the inclusion of the following foreign equipment in the issuance of Federal Shipyard Financing Program (“Title XI”) loan guarantee to upgrade shipyard facilities in Galveston and Port Arthur Texas by GC Asset Holdings LLC. (GCAH)

Automated Panel Line

Automated T-Beam Line

Automated Micro Panel Line

CNC Plate Bender

Self Propelled Modular Transporters (SPMTs)

GCAH has submitted requests to MARAD to waive the domestic content requirement for the above foreign equipment necessary for steel fabrication, block assembly, and overall vessel assembly pursuant to 46 CFR 298.13(b)(2), as part of their application for a Title XI loan guarantee. Each waiver request included the certification required by 46 CFR 298.13(b)(2), stating that the above items are either not available in the United States on a timely or price-competitive basis or the domestic item or service does not meet the minimum required standards, or is not of sufficient quality. MARAD's Office of Shipyards and Marine Engineering (OSME) reviewed the foreign equipment in the waiver requests and validated that the waiver requests satisfy the Title XI regulatory requirements.

The project consists of construction financing for the automated panel lines, T-Beam Lines, Plate Benders, and SPMTs, which will provide cost-efficient solutions to modernize, meet current industry standards and increase the efficiency of the shipyards. The approval of the domestic content waivers for the equipment is necessary to finalize the Title XI loan guarantee for the project.

MARAD will only consider a domestic content waiver when the conditions in 46 CFR 298.13 have been met. Rather than affirmatively requiring recipients to meet a domestic content standard as a condition of financial assistance, under Section 298.13(b)(2), MARAD excludes from the loan guarantee amount the costs of foreign components and services used in shipyard modernization unless MARAD grants a waiver for those costs. If the foreign component is

available in the U.S. on a timely or price-competitive basis and is of sufficient quality, then MARAD will not approve the inclusion of that cost as part of the financeable cost of a project.

MARAD will consider all comments received in the initial 15-day comment period during our evaluation of the waiver request. Comments received after this period, but before final determination, will be considered to the extent practicable.

Public Participation

How do I prepare and submit comments?

To ensure that your comments are correctly filed, please include the title of this document in your comments.

If you are submitting comments electronically as a PDF (Adobe) File, MARAD asks that the documents be submitted using the Optical Character Recognition (OCR) process, thus allowing MARAD to search and copy certain portions of your submissions.

Please note that pursuant to the Data Quality Act, for substantive data to be relied upon and used by the agency, it must meet the information quality standards set forth in the OMB and DOT Data Quality Act guidelines.

How do I submit confidential business information?

Confidential business information (CBI) is commercial or financial information that is both customarily and actually treated as private by its owner. Under the Freedom of Information Act (FOIA) (5 U.S.C. 552), CBI is exempt from public disclosure. If your comments contain commercial or financial information that is customarily treated as private, that you actually treat as private, and that is relevant or responsive to this notice, it is important that you clearly designate the submitted comments as CBI. Please mark each page of your submission that constitutes CBI as “PROPIN” to indicate it contains proprietary information. MARAD will treat such marked submissions as confidential under the FOIA, and they will be exempt from release. In addition, we recommend that you submit at least a summary of the information that is otherwise considered CBI and from which you have deleted any claimed CBI. Any comments MARAD receives which are not specifically designated as CBI will be available to the public.

Will the agency consider late comments?

We will consider all comments received before the close of business on the comment closing date. To the extent possible, we will also consider comments received after that date.

How can I read the comments submitted by other people?

MARAD may make the comments it receives publicly available by posting them to its website after the closing date.
