Strategic Objective: Assure that sufficient sealift capability and intermodal transportation infrastructure exists to support vital national security interests.

Vision: A maritime system that serves America with American ships and American labor.

<u>Mission</u>: Section 1301 of title XIII of the Merchant Marine Act, 1936 declares that it is the policy of the United States that "merchant marine vessels of the United States should be operated by

highly trained and efficient citizens of the United States..." The Maritime Administration promotes the development and maintenance of an adequate, well-balanced educated and trained United States merchant marine.

Program

Mariner Recruitment and Retention – The future of our Nation is dependent upon the ability of our maritime transportation system (MTS) to transport the goods and raw materials that sustain the economy of our country. People run the system. The success of our nation's MTS depends on recruiting, training and ultimately retaining professional mariners to ensure that our country's

MARAD established the Maritime Careers Working Group, recognizing that maritime employment opportunities lacked visibility, that employment in the maritime industry is usually not associated with viable long-term careers, and that the maritime industry, in general, received little consideration.
